Furthermore, this paper should reveal what specific factors need to be considered and which challenges can occur when professionally

operating a blog. Thus the digital economics' research, for example, the literature of Kollmann, Reynolds or Wirtz, provide a broad base concerning the revenue models and the categorization of classical E-Businesses such as E-Commerce-Websites. However it does not scrutinize the particular requirements of weblogs.
